The interim WSC meeting will be online 28 February and 1 March 2025. Each day will have two two-hour sessions, 11am–1pm and 2pm–4pm, Pacific Standard Time.

**The 38th World Convention, The Power of Love**, will be in Washington, DC, 29 August–1 September 2024. The convention will be centered at the Walter E Washington Convention Center in downtown DC. We plan to go on sale in the last quarter of 2023 and will have information about hotels at that time as well. #### WORLD SERVICE CONFERENCE 2022

The second virtual meeting of the World Service Conference is a wrap. In August 2021, conference participants decided to postpone the full WSC meeting until 2023, in the hopes that the financial and public health conditions would allow for an in-person meeting by then.

Participants decided to hold an interim virtual WSC in 2022 to make decisions required by law and policy and to decide on A Spiritual Principle a Day. WSC 2022 convened online the last two Fridays and Saturdays of April (Saturdays and Sundays for CPs over the dateline) to make

decisions on the motions in the Interim CAR/CAT, all of which passed with consensus or unanimous support. WE HAVE A NEW BOOK! The motions and vote counts are posted on [www.na.org/conference](http://www.na.org/conference).

#### A SPIRITUAL PRINCIPLE A DAY

A Spiritual Principle a Day is now NA Fellowship-approved literature, which means it can be read in NA meetings. Typically, it takes about six months from approval for a book to be available for sale. Given the disruptions in the supply chain that most businesses are experiencing and the delays from most printers, SPAD may take longer, but soon we plan to offer a free email subscription to the daily reading. The subscription will be similar to the Just for Today subscription and include a twice-annual email encouraging contributions to NA World Services. This is currently available now!

Next on the agenda is the physical (in person) conference, slated to resume at the end of April of 2023. There is a proposed idea implemented by NAWS to move the conference cycle from 2-year cycle, to a three year cycle, and is in discussion. Details will be reported as we learn more about the proposal.

We have requested reserving Camp Posey for early next year, in order to perform our next Regional Assembly. We should have our motions released around November, and we will be offering our guidance in the GSR's to make decisions on the upcoming motions. As you know, our terms as RD and RD alternate have been extended, and we will be visiting elections for RD alternate and RD will be visited sometime after the end of the current conference cycle.

Our next adventure is WSLD, in which we will be physically attending one of our Quarterly Zonal Meetings. WSLD (Western Service Learning Days) is being hosted in Denver CO. this year, starting Oct. 27, 2022 – Oct. 30, 2022. This is an annual Service Convention style event. This is where we (Narcotics Anonymous) and the local community leaders, (Police, Hospitals, Correctional, and Treatment facilities, get together and discuss how addiction affects the local communities and how they address it. Also, we need to discuss financials today.

Our next event looks like we will be headed to Portland Oregon Jan 19-22, 2023, for our annual WSZF meeting. The RD Team has tossed our hat in the ring and offered to host a future WSZF

in Ventura. We are looking into the possibilities. We will have to discuss financials in the near future.

Obviously, we will be rather busy for about the next several months coming and we will have to engage in the conversation of funding. We are honored to serve this body and hope that we have your confidence in our service. Thank You!
